- 3. Sealed bids must be submitted to the office Paiyun Rural Municipality, Huwas Parbat.12:00 pm on 2075/03/16(30th june 2018) Bids received after this deadline will be rejected.
- 4. The bids will be opened in the presence of Bidders' representatives who choose to attend at 2075/03/16(30th june 2018) 2:00 pm the office of Paiyun Rural Municipality, Huwas Parbat. Bids must be valid for a period of 45 days after bid opening and must be accompanied by a bid security amounting to a minimum of following amount which shall be valid for 30 days beyond the validity period of the bid. If bidder wishes to submit the Cash Security, the cash should be deposited in Account No. 0660300000003000010 (Ga-3-1 DHARAUTI) at Nepal Bank Ltd. Kusma Parbat. and submit the receipt of the deposited amount of cash along with the Sealed Quotation.
- 5. If the last date of purchasing and /or submission falls on a government holiday, then the next working day shall be considered as the last date. In such case the validity period of the bid security shall remain the same as specified for the original last date of bid submission.
