Bidders are required to follow the electronic bid submission procedure as specified in e-GP System Operating Guideline 2074 issued by PPMO which are available in e-GP system www.bolpatra.gov.np/egp. Bids received after this deadline will be rejected.
- 6. The bids will be opened in the presence of Bidders' representatives who choose to attend at 13:00 Hrs on 31st Dec, 2024 (2081/09/16) at Paiyun Rural Municipality Office, Huwas, Parbat.
